GENERAL REQUIREMENTS LEGAL OPINION COMPETITION ALSA ENGLISH CONTEST 2020

1. The Legal Opinion Competition only can be participated by undergraduate (S1) level students of the Faculty of Law from all universities in Indonesia.
2. Legal Opinions that are submitted in the ALSA English Contest are works that have never been published in any media.
3. Plagiarism is prohibited in writing Legal Opinions. If the jury or committee finds plagiarism in writing further, the participant will be disqualified.
4. ALSA Local Chapter Universitas Brawijaya has the right to use the Legal Opinion that submitted to the ALSA English Contest for publication on media partners or on social media ALSA English Contest and ALSA Local Chapter Universitas Brawijaya.
5. Each university has no limit in sending the number of delegates, but each delegates or individual can send only one Legal Opinion work.
6. To maintain the neutrality of the jury in assessing process, when delivering the results of the Legal Opinion work to the jury, the names and the origin of the participant will not be displayed.
7. The submission for Legal Opinion will be opened from November 12th 2020 - November 24st 2020, the jury will assess the participant's works from November 24rd 2020 - November 27th 2020, the winner will be announced at the closing ceremony, which is on November 29th 2020.
8. All of the participants must attend the opening ceremony and seminar on November 27th 2020, and also the closing ceremony on November 29th 2020.

WRITING PROVISIONS LEGAL OPINION COMPETITION ALSA ENGLISH CONTEST 2020

1. The following criteria of the Legal Opinion writing format:
 - a. A4 paper size (210mm x 297mm).
 - b. Times New Roman font, size 12 and space 1,5 (distance between paragraph).
 - c. Aligning right left/justify.
 - d. A new paragraph begins 1 cm from the left margin.
2. The Legal Opinion must be written in English.
3. Minimum use of words is 2500 words and the maximum is 3000 words outside the footnotes.
4. Reference is required and it's prohibited from using references from Wikipedia and blogs.
5. Legal Opinion assessment aspects:
 - a. Legal Analysis.
 - b. Knowledge of International Law.
 - c. Argument.
 - d. Writing structure.
 - e. Grammar Assessment
